ABSTRACT

Decomposition and longevity of in-stream woody debris: a review of literature from North America, by R. Scherer. *In* Proceedings, Forest Land–Fish Conference II: Ecosystem Stewardship through Collaboration. April 26-28, 2004, Edmonton, Alberta. G.J. Scrimgeour, G. Eisler, B. McCulloch, U. This paper presents a brief summary of a literature review completed to document the current state of knowledge regarding the decomposition and longevity of in-stream woody debris in western Canada. The summary provides brief overviews of riparian management implications, decomposition processes and rates, sensitivity of in-stream woody debris models to decomposition parameters and a summary of the longevity of in-stream woody debris.
